- The harvesting of the seafood

- The transportation of the seafood
- The storage of the seafood before delivery
- Misidentification of species
- Spoilage, contamination, or deterioration occurring before receipt by the restaurant
- Any inaccurate information provided by me regarding the seafood

I understand and agree that Grove Bay Hospitality Group reserves the absolute right to reject any seafood for any reason, including concerns regarding freshness, quality, safety, species identification, legal harvest status, or regulatory compliance.
